Dear Members of the New Hampshire Liquor Commission:

I am writing to express a concern regarding the application for a restaurant license submitted by Saco River Brewing Taphaus, ("Saco River Brewing") currently on today's Enforcement agenda. Based on their current licensing status, the Commission's granting them a restaurant license may result in a violation of RSA 179:11, specifically the prohibited interest clause.

As Saco River Brewing currently holds a beverage vendor license, *see attachment*, and is distributed in New Hampshire through a licensed wholesale distributor, and since they do not plan to produce their beer or beverages on-site, granting them a restaurant license may conflict with RSA 179:11's restrictions on business interests. This may unintentionally violate existing statutory requirements, create issues for other industry stakeholders and disrupt the three-tier system.

I respectfully request that the Commission carefully review this matter to ensure compliance with RSA 179:11 and to avoid any unintended consequences related to licensing.

Thank you for your attention to this issue. I trust that the Commission will take the necessary steps to ensure that all licenses are in full compliance with state law.
